Contestant Rules and Regulations

1. Only home prepared fruit preserves will be accepted. These can be a jam, marmalade, or jelly. The preserve must be prepared by the contestant submitting the preserve entry for judging. Amateur preserve makers only. Professional chefs and restaurant entries will not be accepted.
2. Entries must be half pint or larger, vacuum sealed (no paraffin) and be cooked in a sanitary kitchen.
3. Preserves must be made from scratch. No store bought or can fillings can be used.
4. No artificial preservatives or artificial sweeteners are to be used in the making of the preserve.
5. One preserve per applicant, please.
6. There is a nonrefundable \$5.00 entry fee per applicant due by noon on May 6, 2017 (cash or check made payable to the Old Town Newhall Farmers Market). Contestants can register at the Market Information Booth each Saturday. Applications are also available for download at www.oldtownnewhall.com.
7. Only the first 20 entries will be entered in the contest. To be considered, application must be complete and submitted with a printed copy of the recipe. No incomplete entries will be considered.
8. All entries become the property of the Old Town Newhall Farmers Market. We reserve the right to use your entry in all print and electronic media, and to edit it for brevity and clarity.
9. Contestants must bring their preserves to the judging area by 9 a.m. on Saturday, May 13, 2017. Judging will take place between 10 a.m. and 11 a.m. with the winners announced shortly thereafter.
10. Judging will be based on flavor, texture/consistency, pack and color.

Sweet Preserve "Market Money" awards:

1st place \$75 Market Money, 2nd place \$50 Market Money; and 3rd place \$25 Market Money.

All winners must be present when awards are announced and presented.
