OVERVIEW

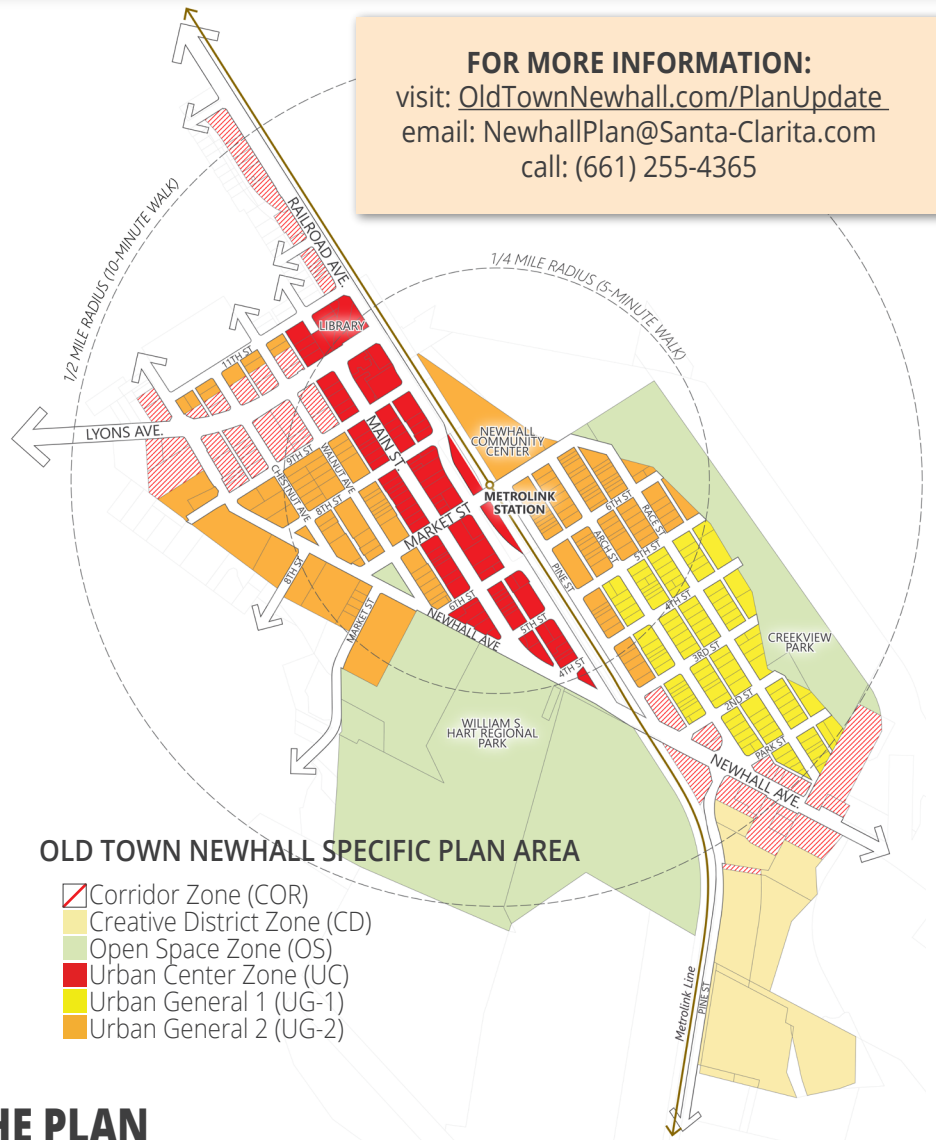
The City of Santa Clarita is currently updating the existing **Old Town Newhall Specific Plan** – the regulatory document that establishes the overall vision for Old Town Newhall and guides its growth, development, and revitalization.

Since 2005, the Plan has been successful in revitalizing Old Town Newhall, encouraging new use and development, and transforming a state highway into the City of Santa Clarita's official **Arts & Entertainment District**.

Building on this success, the City is updating the Plan to recognize the accomplishments of the past and fine-tune it for the next 15 to 20 years. Informed by community input.

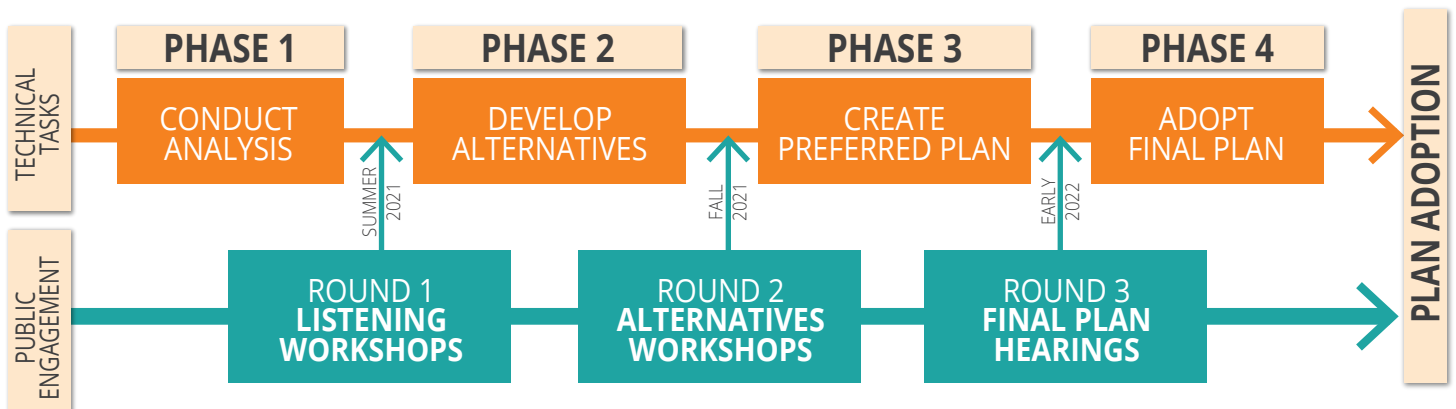

THE PROCESS TO UPDATE THE PLAN

Whether you're a resident, business owner, developer, or visitor, by engaging in this effort, you will be able to shape the way Old Town Newhall grows over the next 20 years. The Plan update process commenced in March 2021. It is expected to last 10 months, culminating in a City Council hearing in early 2022 for review and potential adoption. The update process will play out over four phases as illustrated below.



FREQUENTLY ASKED QUESTIONS

WHAT IS THE OLD TOWN NEWHALL SPECIFIC PLAN?

The current Old Town Newhall Specific Plan was adopted in 2005. The Plan establishes the overall vision for Old Town Newhall and has successfully guided its growth, development and revitalization over the last 15 years. The Plan is a regulatory document that codifies development standards, design guidelines and implementation measures for the development of buildings, places, streets and infrastructure. These regulations are ultimately intended to implement the goals and policies of the City's General Plan, as they apply to the 20-block area of Old Town Newhall.

HOW WILL AN UPDATE TO THE OLD TOWN NEWHALL SPECIFIC PLAN BENEFIT ME?

The proposed Plan update will be shaped by the ideas and input of the community and will generally ensure that future improvements are addressing your needs and aspirations. Specifically:

- If you are a property owner within the Plan area, you can expect to see greater clarity on what and how you can use and develop your property.
- If you are a resident of the Plan area, you can expect to see more amenities that address your needs, as well as safer streets and opportunities for jobs and housing.
- If you are visitor, you can expect to see Main Street and Old Town Newhall build on their success as vibrant destinations that offers a mix of retail, food and creative experiences.
